# Startup20

## INCLUSIVE, DECISIVE AND ACTION-ORIENTED

JULY 03-04, 2023 | GURUGRAM

**W**hen India assumed the Presidency of the G20 on December 1, 2022, the Honorable Prime Minister Narendra Modi famously announced that India's Presidency of the G20 will be "inclusive, decisive, and action oriented". Looking back, we can safely say that Startup20, the only new Engagement Group launched during India's Presidency, has delivered on all three dimensions.

Under India's leadership the group has gone from zero to one. It has produced a first ever Policy Communiqué for the G20 leaders comprising a compelling set of recommendations for weaving the national startup ecosystems into a global one. The cherry on the icing is, the Brazil Presidency has decided to carry the group forward next year.

Startup20 represents a vast canvas. The startup ecosystems across G20 nations add up to over 850,000 startups; 1600 unicorns; 20,000 incubators; and 41,000 investors such as Angel Investors, Venture Capitalists, and Private Equities. There are startups in all sectors of the economy. Every G20 nation today is supporting startups. The Startup20 Engagement Group set out to





harness this energy through an inclusive, decisive, and action-oriented agenda.

## INCLUSIVE

Startup20 developed the Policy Communiqué through an intensely participatory process. Over four physical meetings in Hyderabad, Gangtok, Goa, and Gurugram, more than 500 international delegates from 25 countries and 1000 stakeholders from India participated. More strikingly, the Draft Policy Communiqué the group produced was opened up for public consultation. This move spurred something unexpected: across India and other nations over 40 startup meetings sprang up to discuss the document, resulting in over 800 comments from 15 nations. They represented views of startups, investors, ecosystem builders, policymakers, and more. It would not be an exaggeration to say that it was this process where no one was excluded that made the final step of building consensus painless.

Startup20 built itself up through deeply democratic processes. The very scaffolding comprising five task forces — foundation, alliances, finance, inclusion, and sustainability — emerged through an intensive brainstorm among over twenty five nations at the inception meeting in Hyderabad. Furthermore, the

chairs and co-chairs of these task forces were elected by the groups. The result was, there was a deep sense of ownership to the task at hand.

Startup20 architected itself to listen to both top-down and bottom-up voices. Early on, the group recognized that, while its Task Force Councils, where the core policy topics were discussed and developed, comprised of subject matter experts and highly effective leaders, there needed to be a mechanism to hear the voices of the global ecosystems bottom-up, as that's where the real action takes place. To capture this energy, Startup20 created a platform called Startup20x, allowing ecosystems across G20 nations to co-brand and globalize their events. In the words of Mahatma Gandhi, Startup20x is created with the vision of 'Antyodaya' of the global startup ecosystem. This platform will continue as the presidency moves to Brazil.

## DECISIVE

The overarching goal of Startup20 is to provide startups from G20 nations an equitable voice in the global economic discourse. As the work progressed, the group recognized the sincere efforts of every G20 nation to support startups, and has proposed decisive measures to weave the national startup ecosystems into a global one.







In its inception year, the group has called upon G20 leaders to raise their joint annual investment in the global startup ecosystem to US\$ 1 trillion by 2030. To harmonize the global startup ecosystem, while retaining the autonomy of the national ecosystems and helping startups achieve full potential, the group has recommended (a) adopting a Global Startup Definition Framework and governance, and due diligence standards (b) creating channels to access global financing, market, and talent (c) emphasizing inclusive practices to support diverse and under-represented groups and (d) building capacity to identify and scale startups that address our common challenges such as achieving the Sustainable Development Goals.

To implement these measures, it has proposed building a networked institution of existing nodal agencies across G20 nations. To measure the success of these joint actions of G20 nations the group has suggested four measures: ability to scout promising startups internationally, fund them collaboratively, mentor them contextually, and scale them globally.

The clarity and magnitude of this commitment by G20 as well as invited nations speaks for itself. Reaching an annual investment of US\$ 1 trillion by 2030 amounts to an investment rate that is 2.5-3 times that of the average rate over the past years. The group has resolved that such a goal, while ambitious, is achievable with joint commitment.







## ACTION-ORIENTED

The work of Startup20 has already produced several actionable outcomes. For the first time the world came together to produce a consensus-based Startup Definition Framework. The framework is based on the existing definitions of startups across the G20 countries, the academic literature, and expert consultations. Such a framework is intended to help stakeholders understand what makes an entity a “startup” in different parts of the world and how to “value” it. Demystifying this question is at the heart of addressing the fundamental challenge of bringing startup valuation in line with the real value.

Recognizing that the true potential of startups will not be realized until startup ecosystems establish a culture of accountability, transparency, and ethical behavior at all levels through self-governance, the group has produced a Startup Governance Framework. This framework is a comprehensive guide for startup founders to take practical measures to embrace corporate-like governance at early, mid, and mature stages. The framework aspires to ensure that governance need not be an afterthought no matter what is the stage of startup.

Leveraging the existing commitment of G20 nations towards meeting the sustainable development goals

(SDGs), the group published a Framework for Identifying and Guiding SDG-focused Startups. This framework tackles the important challenge of identifying and fostering startups that are truly SDG-focused and proposes ways to scale them to global impact.

Acknowledging the importance of including the under-represented groups and communities on one hand, and the challenge of catering to the great diversity of who it is that is considered under-represented on the other, the group has produced a cataloging of Inclusive Practices Across G20 Nations when it comes to building innovation ecosystems.

Finally, to ensure that the above actions are taken consistently and effectively, the group has proposed an Architecture for a Global Networked Institution. This framework envisages a three-tier networked institution comprising a Global Network of Centers (GNC) that will weave together the existing regional nodes (RNs) via regional network centers (RNC) that acts as their nodal access point or point of contact.

What Startup20 has achieved over the past six months lays the foundation for the next decade of work in building the global startup ecosystem. This is the power of fully embracing the philosophy undergirding India's G20 Presidency: One Earth, One Family, One Future. ■

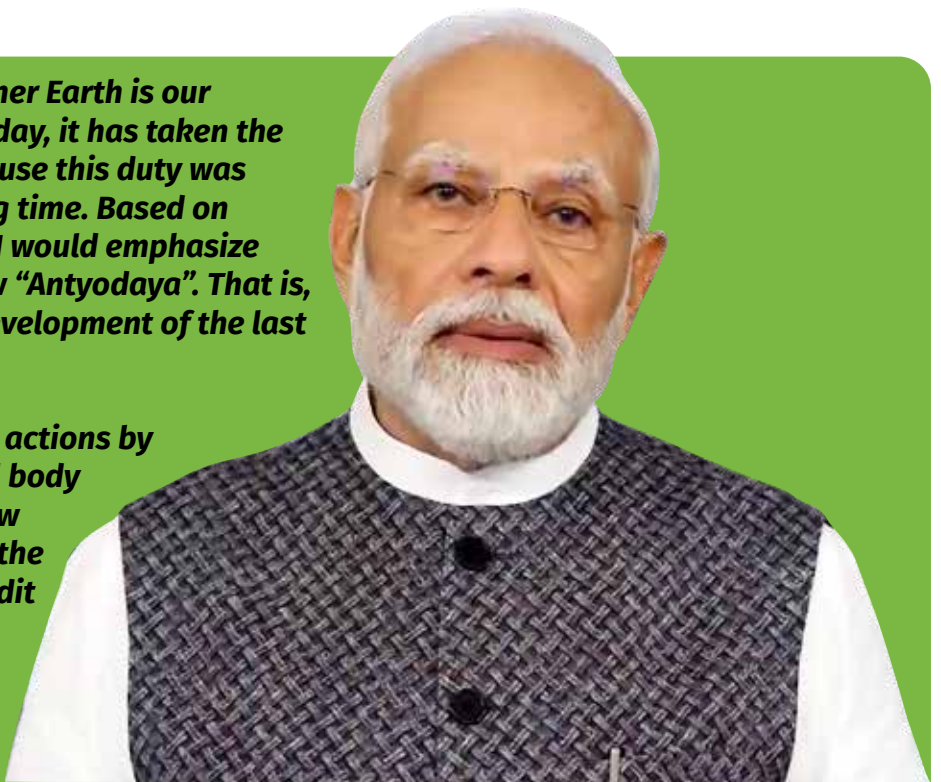
# Environment and Climate Sustainability Ministers' Meeting

# Positive Outcomes & Promising Achievements

## ENVIRONMENT AND CLIMATE SUSTAINABILITY MINISTERS' MEETING

**T**he Environment and Climate Sustainability Working Group (ECSWG) wrapped up its work with the Environment and Climate Ministers' meeting on July 28, signifying a successful conclusion to their gathering.

On December 01, 2022, India assumed the G20 Presidency, aiming to build upon previous accomplishments and establish a path of ambition to lay the groundwork for the succeeding Presidency. Amidst a challenging global

landscape, the ECSWG took up the vital role of driving G20 cooperation in addressing complex and multi-dimensional climate and environmental challenges. Aligned with India's G20 vision as laid out by Prime Minister Narendra Modi, ECSWG set forth on a mission to foster an integrated, comprehensive, and consensus-driven approach to combat climate change effectively.

At the outset, the ECSWG issued a comprehensive issue note outlining its primary objective: to strive for the restoration of degraded landscapes, the preservation of marine and terrestrial biodiversity, and the reduction of intensity of resource consumption and environmental footprint. To achieve sustainable climate, environment, and biodiversity goals, the ECSWG identified three key priorities. First, arresting land degradation, accelerating



ecosystem restoration, and enriching biodiversity. Second, promoting a sustainable and climate-resilient blue economy; and third, encouraging resource efficiency and circular economy. How climate change affects each of these subjects was dealt with. The thematic priorities embedded the consideration of principles of sustainable lifestyles, which also echoed the ethos of Mission LiFE, launched by PM Modi globally in 2021. By adopting an inclusive, ambitious and action-oriented approach, the ECSWG sought to convey a united message from the G20 nations to the world, underscoring the significance of these priorities.



The 1st G20 ECSWG meeting was held in Bengaluru from February 09-11, 2023, which saw active participation from delegates, demonstrating their support and dedication to collaboratively work towards the objectives of the three priority areas outlined by the Presidency. The 2nd G20 ECSWG meeting, which was held in Gandhinagar, involved extensive deliberations on various initiatives under the identified themes, along with a dedicated session focused on discussing the outline of the outcome document or the statement from the G20 Ministers to the world. The focus of this meeting was on Water Resource Management with a side event hosted, followed by thematic site visit to the Adalaj Vav, Sabarmati siphon, Sabarmati Riverfront and Narmada Main Canal, showcasing India's ancient water management practices and the nation's long-standing tradition of conserving water resources to the G20 delegates.

The 3rd G20 ECSWG meeting took place in Mumbai from May 21-23, 2023. It involved extensive discussions on the draft Outcome Document with deliberations tuned towards driving consensus amongst the G20 countries on various challenging topics. The theme of this meeting was based on the theme of Blue Economy. A Mega Beach clean-up was organised, raising awareness about community participation in safeguarding coasts and oceans. The event received overwhelming participation, and delegates pledged to protect beaches. Additionally, the Ocean 20 dialogue involved experts-led discussions on addressing ocean-related challenges.

In addition to the work conducted during in-person ECSWG meetings, our Presidency conducted over 45 virtual meetings, some lasting up to 7 hours or more,

with G20 delegates, in order to gain maximum consensus before the final ECSWG meeting, given that the working group's mandate is vast and extensive. The aim was to deliberate meticulously, line-by-line, and find common ground among the 20 member nations on critical issues, while also considering perspectives provided by the invitee countries and international organisations.

The 4th G20 ECSWG meeting, along with the Environment and Climate Ministers' meeting, took place in Chennai from July 26 to 28. After seven months of dedicated efforts, intense negotiations, and round-the-clock deliberations at the 4th ECSWG meeting, India's Presidency achieved a significant milestone - the issue of Outcome Document and Chair Summary by the G20 Environment and Climate Ministers on July 28. This historic achievement saw unanimous agreement on 64 out of 68 paragraphs by all the G20 Environment and Climate Ministers. Moreover, they adopted the 'Chennai High-Level Principles on Sustainable and Resilient Blue/Ocean-based Economy', marking a remarkable step towards fostering a sustainable and resilient ocean-based economy.

This is a landmark outcome for a number of reasons. India's Presidency was successful in facilitating agreement among G20 countries on recognising the importance of limiting global temperature rise to 1.5 degrees, adaptation action and loss and damage, the upcoming global stocktake, economy wide emission reductions, and sustainable lifestyles to combat climate change. G20 ministers unanimously emphasised on the need for actions to address interconnected climate and environment challenges and reiterated G20's leadership role in tackling climate change and ambitious action



across all pillars of the Paris Agreement. In the domain of Mitigation, conversations emerged around aligning 2030 NDCs (Nationally Determined Contributions) with the Paris Agreement, emphasizing Long-Term Low Emission Development Strategies (LT-LEDs), and engaging constructively in the Mitigation Work Programme. The G20 also stressed on the urgency to enhance cross-sectoral adaptation and building resilience to safeguard livelihoods and protect developmental achievements amid changing climate, especially in developing nations. Additionally, the significance of scaling finance for adaptation and the upcoming Global Goal for Adaptation was highlighted.

G20 Ministers also noted the role of development choices for prosperity and wellbeing of current and future generations. For the first time in G20, all members expressed their determination to end plastic pollution, including in the marine environment. An action-oriented roadmap for the restoration of forest fire and mining impacted areas, given these are biodiversity rich, has been established, marking the first instance of such an initiative in an international forum. The Gandhinagar Implementation Roadmap aided by the Gandhinagar Information Platform aims to provide a global template for restoration. Through this outcome, G20 members reiterated their commitment to achieve the Kunming Montreal Global Biodiversity Framework's 2030 mission to take urgent action for halting and reversing biodiversity loss, and its 2050 vision of living in harmony with nature, and supported implementation of several of its targets.



Despite significant progress, certain areas proved challenging for the G20 to reach a consensus. Key issues, such as achieving net zero energy systems, tripling renewable energy capacity, phasing down unabated fossil fuels, and ensuring access to low-cost financing for developing countries among others remained subjects of diverse viewpoints. While some G20 members stressed on the urgency to achieve a global peaking of emissions by no later than 2025 and reducing emissions by 60% by 2035 compared to 2019 levels, the importance of developed countries reaching net zero status by 2040 was emphasized.

Our Presidency also created a wealth of knowledge in this working group with the development of 10 presidency documents. The leaders thanked India's Presidency for its efforts in developing the compendiums of best practices in water management, mining affected areas, and forest fire impacted areas, conducting technical study on 'Accelerating the transition to a sustainable and resilient blue economy', and technical documents on important topics like Knowledge Exchange on Circular Economy in Steel Sector, Extended Producer Responsibility, Circular Bioeconomy. To strengthen the G20 Global Land Initiative, the Presidency also came up with 'Gandhinagar Implementation Roadmap' and 'Gandhinagar Implementation Framework' for voluntary adoption by G20 members.

The launch of an industry-led Resource Efficiency and Circular Economy Industry Coalition (RECEIC) marked a significant milestone under India's G20 Presidency. On the sidelines of the 4th ECSWG meeting, the industry coalition was launched in the presence of G20 Environment Ministers from 8 countries. Thanking the Indian Presidency for its efforts in launching RECEIC, G20 Ministers also invited the G20 Resource Efficiency dialogue to engage with RECEIC and leverage synergies in future.

The ECSWG and Ministerial Meeting concluded on a positive note, with all G20 Ministers showing unity in their commitment to tackle urgent global climate and environmental challenges. The successful outcomes achieved at ECSWG have laid a strong foundation for the upcoming COP and the next G20. ■

# A Historic Leap

## LABOUR AND EMPLOYMENT MINISTERS' MEETING

**P**rime Minister Narendra Modi had at the very outset said that India's G20 agenda will be inclusive, ambitious, action-oriented, and decisive. The Labour and Employment Ministers' (LEM) meeting for the G20 Employment Working Group (EWG), which

concluded in Indore on July 21, succeeded in furthering this agenda.

Under India's G20 Presidency, the Indore LEM meeting marked a significant milestone with the adoption of the Outcome Documents and Chair's Summary. The Outcome Documents reflect the collective resolve of the G20 countries to address the pressing labour challenges facing the world of work today.

The EWG's mandate is to address priority labour, employment and social issues to develop strong, sustainable, balanced, inclusive and job-rich growth.



The group's work is crucial in shaping labour policies and practices across the G20 countries, impacting two-thirds of the global population.

Under the Indian Presidency, the EWG identified three priority areas:

- ◆ Addressing global skill gaps
- ◆ Gig and platform economy and social protection
- ◆ Sustainable financing of social protection

World over, these issues are emerging as challenges for national governments. Under the Indian Presidency, four EWG meetings in Jodhpur, Guwahati, Geneva, and Indore preceded the LEM meeting. These meetings were instrumental in shaping the discussions and outcomes of the LEM meeting.

The LEM adoption of the Outcome Documents has been a landmark achievement. In a historic move, the G20 LEM made progress in fostering consensus on broader political issues. For the first time in India's Presidency, the G20 members in the LEM meeting agreed on the crucial paragraph, which speaks about respect for multilateralism and international law and the purposes and principles of the UN Charter. PM Modi's message which stated that 'today's era must not be of war' was also agreed to by consensus by all G20 in para 16 of the Outcome Document. This is a significant acceptance of India's appeal for peace and it steered the G20 process towards a robust consensus.

The Outcome Documents represent a roadmap to address challenges across the three EWG priority areas. Mega-trends, such as digitisation, demographic changes, and green transitions have aggravated global skill gaps, as echoed in the first G20 EWG priority area. The Outcome Document 'G20 Policy Priorities on Strategies to Address Skill Gaps Globally' includes commitments by the G20 nations on basic comparable indicators in respective national surveys for collection and analysis of skill gap data.



These datasets will be captured on the 'ILO & OECD's Skills for Jobs Database portal' whose services, as agreed, will be extended to all the G20 countries. Another outcome is an agreement to develop an international reference classification of occupations — a first globally. These outcomes will benefit the G20 population by





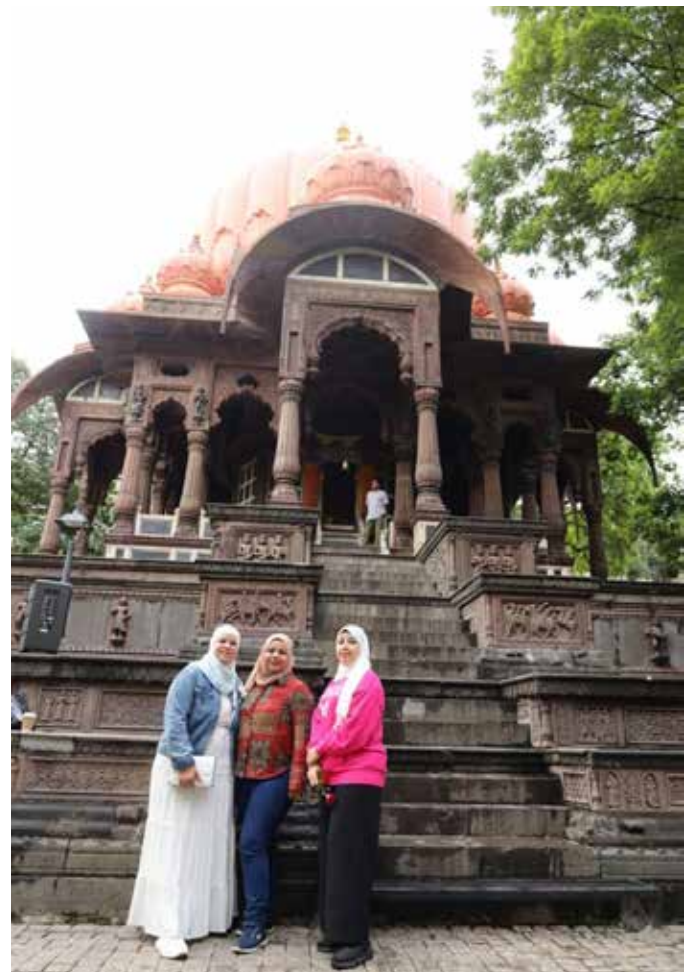
facilitating cross-country comparability, benchmarking, optimal skilling, re-skilling and up-skilling, and mutual recognition of skills and qualifications. PM Modi captured the importance of these outcomes well in his address at the G20 LEM Meeting, when he said, “Mobile workforce is going to be a reality in the future. Therefore, it is now a time to globalise the development and sharing of skills in the true sense.”

The gig and platform economy has spurred a new form of work where the workers participate outside the formal employer-employee relationship. This exponentially increasing workforce largely remains outside the ambit of social protection. The issue of social protection for these workers has therefore been selected as the second G20 EWG priority area under the Indian Presidency. The ‘G20 Policy Priorities on Adequate and Sustainable Social Protection and Decent Work for Gig and Platform Workers’ includes a pledge to provide adequate social protection for all workers, irrespective of classification. Other outcomes

include shared responsibility of all parties for sustainable financing of social protection and social protection across borders for online platform workers through bilateral or multilateral agreements. These will help such workers tide over stresses across the life cycle. In India alone, 7.7 million gig and platform workers are set to benefit from this.

The most recent version of the World Social Protection Report 2020-22 by ILO revealed that only 46.9% of the world’s population receives the benefits of at least one social protection programme. The third EWG priority area under the Indian Presidency

acknowledges the financing gap in ensuring social security coverage for the respective G20 country populations. The outcome document, 'G20 Policy Options for Sustainable Financing of Social Protection', includes a menu of policy options, including contributory and non-contributory mechanisms to ensure sustainable financing of adequate social protection for all. G20 countries may adopt these as per their respective national circumstances. This will enable people globally to avail gainful employment with adequate social protection for all, leading to resilient and inclusive economic development.

The G20 EWG also took the opportunity to showcase the rich cultural and culinary heritage of Indore, in particular, and Madhya Pradesh, in general, through a range of cultural and wellness activities. The Cultural Evening provided an immersive experience of Madhya Pradesh's vibrant cultural diversity with traditional music, dance, and artistic performances. A captivating Heritage Walk was organised around the historic city

centre of Indore. A first in the history of LEM meetings, the sessions were interspersed with regular yoga breaks to rejuvenate the delegates.

The LEM meeting under the G20 Indian Presidency is a crucial milestone. As a testament to the spirit of international cooperation, the 20 G20 countries converged on global labour-related issues and agreed on steps, collectively

and at the national level, to address them. The outcomes of the LEM meeting are a step forward in the right direction, but efforts must continue to develop public policies to promote decent work and labour welfare for workers across the world. After all, we constitute 'One Earth, One Family, One Future'. ■



# Committed to Advancing Global Research and Innovation for a Better Tomorrow

## RESEARCH MINISTERS' MEETING

The G20, an intergovernmental forum comprising 19 countries and the European Union (EU) works to address major issues related to the global economy, such as international financial stability, climate change mitigation, and sustainable development. It consists of most of the world's largest economies, including both industrialized and developing nations.

India assumed the Presidency of G20 in 2023 starting from Dec 1, 2022 until Nov 30, 2023. During its G20 Presidency period, India strived to maintain the continuity of the inter-year agenda under the Research and Innovation Initiative Gathering (RIIG) and Research Ministers Meeting.

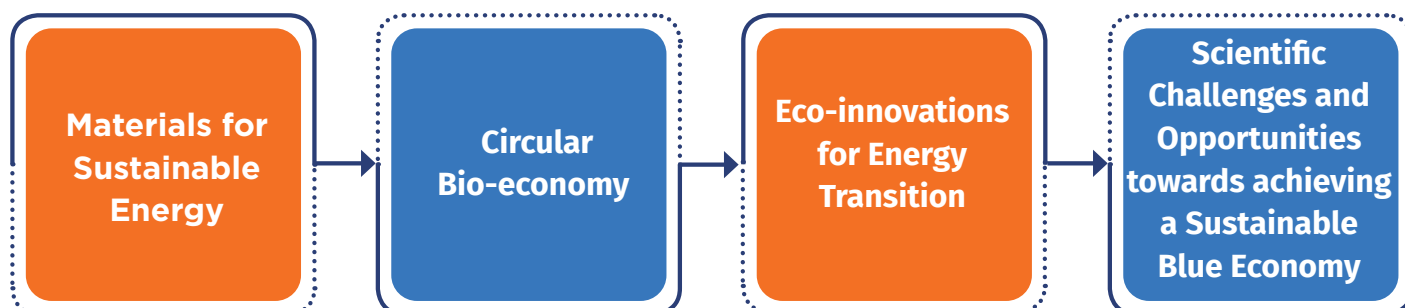
Working under the Presidency-theme of "Vasudhaiva Kutumbakam" or 'One Earth, One Family, One Future',

India identified 'Research and Innovation for an Equitable Society' as the main theme of RIIG during its Presidency. RIIG Meetings were planned to provide platforms for stakeholders at all levels to share ideas and create new partnerships to elevate Research and Innovation as a tool to achieve socio-economic equity.

### Policy Approach and Objective

Government policymakers have an inherent focus on designing frameworks that would generate new markets and sustain macro-economic growth. These mission driven frameworks largely enable the Research-Innovation ecosystem, that leads to creation of new technologies, strengthening the socially beneficial nature of research and innovation. However, more efforts are needed to extend the research and innovation benefits towards achieving socio-economic equity, by enabling greater public participation in setting up research priorities. Through RIIG, G20 member countries proposed to address areas of common interest and working on developing sustainable solutions for science-driven equity.

## PRIORITY ISSUES AND THEMES FOR DISCUSSION



## RIIG CONFERENCES

### Inception meeting, Kolkata, February 9-10, 2023



The Inception meeting of the Research and Innovation Initiative Gathering (RIIG), was held in Kolkata, to discuss research and innovation for an equitable society. A total of 36 foreign delegates representing twenty countries and International Organisations, participated in the Inception meeting. About 40 Indian delegates and special invitees from various scientific departments and organisations of Government of India participated in the meeting.

### Conference on Materials for Sustainable Energy, Ranchi, March 16-17, 2023



#### MAJOR OUTCOMES

The discussions focused on understanding the fundamentals of material development and bottlenecks to achieve efficient large-scale green energy generation and storage. Materials for Sustainable Energy Storage, Solar Energy Utilisation and Photovoltaic Technologies, Materials and Processes for Green Energy, Policies and Programmes for EV Implementation were some of the sub-themes discussed.

The panel discussion on the theme elaborated on the critical need for participating countries in the area of energy and recommended a future roadmap.

## Conference on Circular Bio-economy, Dibrugarh/Itanagar, March 24-25, 2023



### MAJOR OUTCOMES

The deliberations held on the bio-based circular carbon economy with emphasis on the utilisation of biogenic materials and/or bioprocesses by adopting nature-based interventions within the economic system catalyses circularity making the ecosystem more resilient. The discussions provided an opportunity to deliberate and enhance commitments of actions and pledges from key stakeholders towards building a sustainable and circular bio-economy. The meeting focused on connecting thematic issues on agriculture, decarbonisation in industry, Bio-Energy and Bio-resource Management.

This conference marked an important milestone in preparing a roadmap for establishing a transition towards the circular bio-economy.



## Conference on Scientific Challenges and Opportunities towards achieving a Sustainable Blue Economy, Diu, May 18-19, 2023



### MAJOR OUTCOMES

- ◆ Foster knowledge exchange between G20 members on Sustainable Blue Economy
- ◆ How can next-generation technologies support policy and governance to enhance ocean biodiversity conservation and improve coastal and marine spatial planning?

The discussions were held for building appropriate frameworks and processes that recognise and accommodate various values of nature that underpin our social and economic wellbeing, through Blue Economy. Contemporary topics in Marine Biodiversity, Coastal and Marine Spatial Planning, New and renewable off-shore energy were discussed.

## RIIG Summit/Ministerial meeting, Mumbai, July 5-6, 2023



The finalisation of the Chair's Summary and Outcome Document marked the culmination of the G20 research engagements that took place through a series of meetings in different parts of India during India's G20 Presidency in 2023. As the Minister of State (Independent Charge) for Science and Technology I chaired the G20 Research Ministers' Meeting (RMM) on July 05, 2023. More than 100 foreign delegates including Research Ministers from 29 G20 members, invited guest countries and international organisations participated and re-affirmed the critical role of research and innovation for enabling inclusive and sustainable development and resolved to support all efforts for transforming research and innovation systems to respond to the changing world of the 21st century and address the challenges of tomorrow. ■

In the captivating city of Hampi, Karnataka, the 3rd Sherpa Meeting under India's G20 Presidency unfolded against the backdrop of ancient ruins and cultural splendour. Over 120 delegates, including Sherpas and Heads of Delegations from G20 members, invitee countries, and International Organizations (IOs), convened from July 13-16, 2023. Their mission? To engage in crucial discussions and co-author the Leaders' Declaration, a pivotal document to be adopted by G20 leaders at the New Delhi Summit in September.

Guided by Prime Minister Shri Narendra Modi's vision of

inclusivity, ambition, and decisive action, we dedicated three days to negotiate transformative, action-oriented initiatives that encompassed (i) Accelerated, Inclusive, Sustainable, and Resilient Growth, (ii) Accelerating Progress on Sustainable Development Goals (SDGs), (iii) Green Development Pact for a Sustainable Future, (iv) Multilateral Institutions for the 21st Century, (v) Technological Transformation and Digital Public Infrastructure, (vi) Gender Equality and Empowering All Women and Girls.

Emphasizing inclusivity as a core value, the Indian Presidency proposed the admission of the African Union to the G20 fold, recognizing the significance of amplifying the voices of emerging countries and those from the Global South within the forum. Delegates expressed appreciation for India's ambitious draft New Delhi Declaration, particularly its emphasis on women empowerment, and extended support to initiatives aiming at achieving gender equality and empowering all women and girls. Notably, a new working group dedicated to women's issues will convene during Brazil's G20 Presidency next year, backed by broad-ranging support.

This strategic move not only showcased a steadfast determination to address gender disparities but also

reinforced the G20's commitment to realizing inclusive development goals on a global scale.

Beyond the formal discussions, the Sherpas embraced the spirit of camaraderie through bilateral meetings, fostering stronger relationships, aligning priorities, and building trust. Additionally, an informal Sofa Talk session provided a congenial environment for open dialogue, promoting collaboration and mutual understanding amongst the delegates.

Amidst intense deliberations, we immersed ourselves in the rich heritage of Hampi. The UNESCO World Heritage site unveiled magnificent Dravidian-style temples, intricate designs, and monuments. Delegates marveled at the digital exhibition at the Hampi museum, showcasing the city's grandeur and legacy while combining modernity with history.

Exploring historical sites such as the Vijaya Vittala temple, Yeduru Basvanna complex, and the Virupaksha temple, Sherpas witnessed the grandeur of Hampi's bygone era. Vibrant cultural performances, including a mesmerizing display by Ghatam maestro Pandit Vikku Vinayakram and his troupe at the majestic Vijaya Vittala







Temple showcased South India's percussion traditions.

As the sun set over the enchanting ruins of Hampi, G20 Sherpas and delegates carried the weight of our discussions alongside vibrant cultural experiences and the profound historical significance of this extraordinary city. Driven by collaboration and determination, India's G20 Presidency hopes to help pave the way for inclusive global prosperity.

I extend heartfelt gratitude to the Government of Karnataka and the Central Government for their unwavering support and tireless efforts in providing an enchanting home for this meeting. indeed a fitting destination to host the culmination of India’s “ambitious” Presidency at the G20 Leaders’ Summit in New Delhi.

A defining feature of India’s G20 Presidency has been the unmatched scale and spread of the meetings organised throughout the country. Our Prime Minister had envisioned taking G20 meetings to every part of the country to showcase India’s cultural diversity and tourism potential to the world, and resultantly, the G20 has reached more than 50 cities of India. # Imagining a Cyber Success World

## G20 CONFERENCE ON CRIME AND SECURITY IN THE AGE OF AI, NFTs AND METAVERSE

**T**he universalism of traditional Indian philosophy is encapsulated in the motto of India's G20 Presidency "Vasudhaiva Kutumbakam". Mentioned in the ancient scriptures *Maha Upanaishad* and *Hitopadesh*, this message aptly captures the global interconnectedness that defines the modern day cyberspace.

The G20 is essentially a forum for economic cooperation created to address major issues related to the global economy, such as international financial stability, climate change mitigation and sustainable development. Crime and security have traditionally not been discussed under the aegis of G20. However, security of the cyberspace

where, a major share of global economic activity and transactions take place, deserves due attention of the global leadership. The issues involved are intrinsically linked to several of the priorities for the G20 in the year 2023. These include inclusive and resilient growth, technological transformations, public digital infrastructure, strengthening multilateral institutions, etc.

It is with this background in mind that India decided to host a G20 Conference titled “Crime and Security in the

age of NFTs, AI and Metaverse” as a part of its Presidency. Organised on 13th and 14th July, 2023 by Ministry of Home Affairs (MHA), Government of India at Gurugram, Haryana, the conference was a collaborative multi-agency effort which in a way reflected the expanse of the issues involved. Unlike a traditional G20 conference, this was a multi-organizational effort. Ministry of Electronics and Information Technology, National Security Council Secretariat, Ministry of External Affairs, Central Bureau of Investigation, and Department of Telecommunication

were partners from within the government. National Forensic Science University, Rashtriya Raksha University, and Amrita Vishwa Vidyapeetham pitched in as academic partners. Data Security Council of India (DSCI) was the industry partner and M/s Grant Thornton a knowledge partner. Interpol and UNODC were the international collaborators for the event. Coming together of so many agencies indicates the relevance of the conference, readiness of the agencies to work together and thus augurs well for the preparedness for cybersecurity challenges.

This conference brought under one roof, a spectrum of stakeholders of cyberspace for intense discussions on a range of issues. Those in attendance included 75 foreign delegates, 31 international speakers and Subject Matter Experts, Secretaries and senior functionaries of Government of India, Chief Secretaries, Director General of Police, officials of the cybersecurity establishment, Law Enforcement Officers, Chief Information Security Officers of various central organizations, representatives of sectoral regulators, legal fraternity, banks and financial institutions, fintech, ICT service providers, academia and industry bodies. Over 1200 delegates and invitees attended the conference in person and over 24000 witnessed it online.

In the plenary session, participants were unanimous in their concerns about the threats posed by new and emerging technologies and the need for concerted global efforts to address these challenges. The outcomes of the plenary session were captured in the Chair's Summary which reflected the essence of the opinions expressed by various countries and organizations.

Setting the tone for the conference while inaugurating it, Honourable Union Home Minister Shri Amit Shah exhorted the delegates to work towards the following objectives:

- ◆ Achieving convergence in legislative framework to deal with digital offences and establishing mutual assistance mechanisms for apprehending and prosecuting cybercriminals.
- ◆ Establishing modalities for cross border mutual assistance for Threat intelligence sharing and real time response.
- ◆ Creating a common platform for sharing best practices, coordinating regulation and defining global benchmarks through cooperation.



- ◆ Creating a dedicated common 24/7 channel for checking digital financial frauds which would effect preventive, protective and recovery action.

and together work towards achieving a “Cyber Success World”.

Over the two days six technical sessions were held where domain experts from across the world deliberated on various topics covering a vast gamut of issues of crime and security in the context of new and emerging technologies exemplified by AI, NFTs and Metaverse. The sessions were titled:

- i. Internet Governance - National Responsibility and Global Commons
- ii. Securing Digital Public Infrastructure (DPI) amidst Unprecedented Scale of Digitization - Design, Architecture, Policies and Preparedness
- iii. Extended Reality, Metaverse and future of Digital Ownership - Legal and Regulatory Framework
- iv. AI: Challenges, Opportunities and Responsible Use
- v. Connecting Dots in the Dark Net: Challenges of Crypto Currency and Dark-net
- vi. Criminal Use of Information and Communication Technology (ICT) – Evolving a Framework for International Cooperation

These sessions were participative and elicited a range of viewpoints from the speakers and delegates.

Thanks to the Digital India vision of the Hon' Prime Minister, India is fast emerging as a world leader in adoption of digital technologies. There has been an exponential rise in the volume of mobile computing devices, financial transactions, development of a whole new ecosystem of Open Access Digital Public



Infrastructure, the India Stack. These developments have also been accompanied by rising incidents of cybercrime and breaches in cybersecurity as elsewhere in the world. Concurrently, India is emerging as a global Cyber Security hub with an ecosystem of over 250 product companies generating over a billion USD in revenue. An exhibition held along with the conference, provided opportunity for the established companies, unicorns and the start-ups to showcase their Cyber Security products and services before the delegates coming from across the world and different organizations from within India.

The timing of this conference is significant, as it was held a few weeks before the United Nations' Ad Hoc Committee takes up for discussion the Zero Draft of the UN Convention on Criminal Use of Information and Communication Technologies. This convention, when adopted, would provide an international framework for criminalizing misuse of ICT, defining jurisdictions, procedures for enforcement, international cooperation including evidence sharing, data exchange, legal assistance, 24/7 network, technical support and implementation mechanism. During the Conference India emerged as the voice of the Global South to articulate their concerns during the forthcoming UN negotiations and in other fora for an equitable stake in internet governance making international frameworks broad-based. Pitching for a negotiated multilateral global convention under the UN, in his address Shri Amit Shah encouraged the member countries to use the proposed convention for speedy evidence preservation, investigation assistance, capacity building and strengthening national Computer Emergency Response Teams (CERTs).

During the conference the "Cyber Volunteer Squads", drawn from seven premier educational universities, were flagged off. These student-volunteers, who gained valuable insights into issues of cyber space and hands on experience of such events, go back to their campuses and undertake programs to spread cyber awareness amongst the public, identify and flag malicious content, aid law enforcement efforts using their expertise and launch volunteer enrolment drive. This "Whole of Society" effort of the Ministry of Home Affairs is aimed at enlisting community participation in building a cyber resilient society.

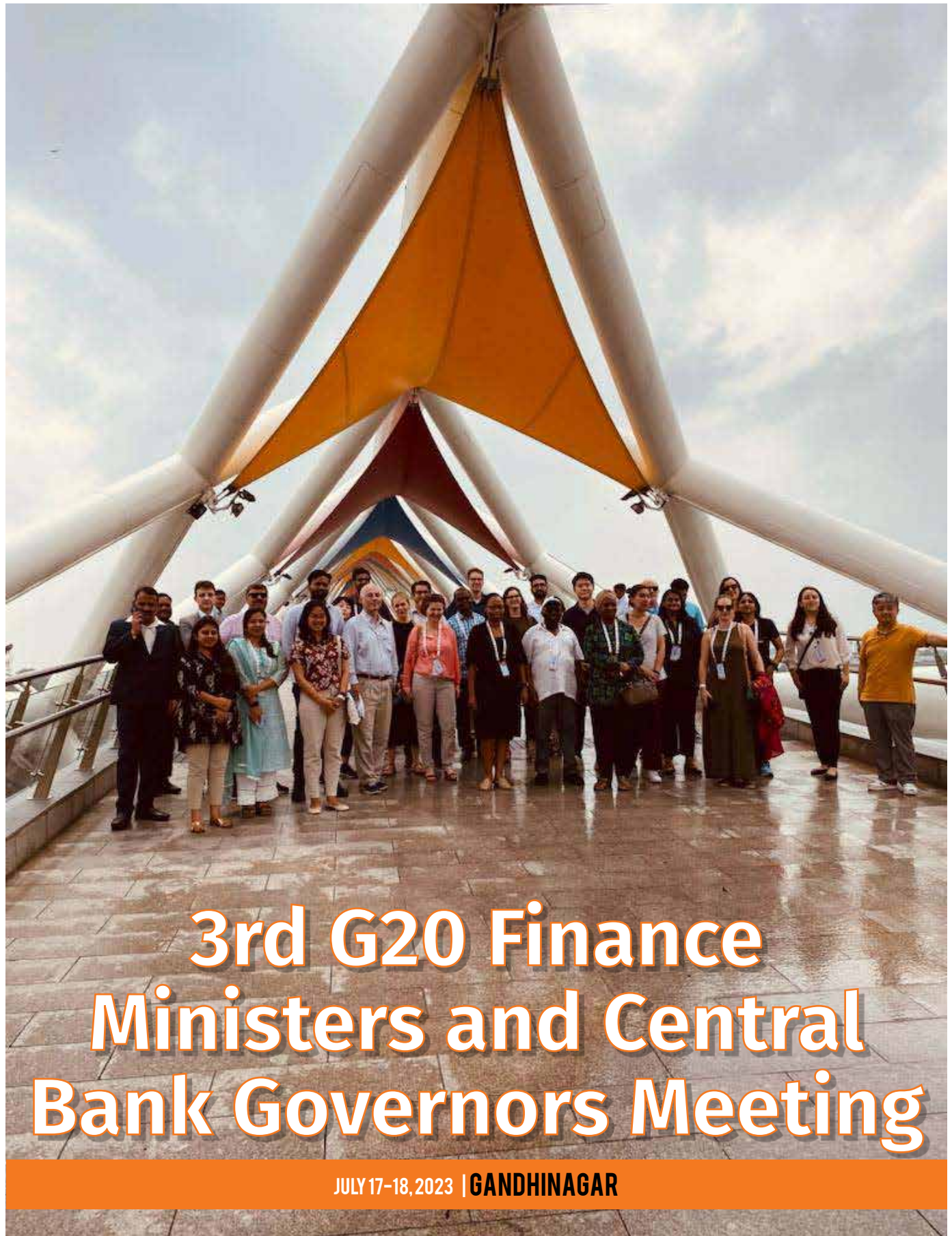
The Chair's Summary released at the end of the deliberations succinctly captured the leitmotif of the conference:



"While emerging technologies such as AI, Big Data, Cloud Computing and other have high potential for creating economic opportunities, and are neutral in nature, these could increase vulnerabilities and expand attack vectors and hence there is an urgent need that these advanced technologies are used ethically, in ways that respect international law, with malicious actors being prevented from exploiting them for criminal and terrorist purposes. It is critical to strengthen and develop capacities of individual states, international organizations and relevant stakeholders to better respond to traditional, non-traditional and new and emerging challenges, including terrorism and its financing, money laundering, misinformation and disinformation".

During the technical session on AI, talking about the uncharted evolutionary trajectory of Artificial Intelligence, NASA's Chief Advisor on Artificial Intelligence, Omar Hatamleh borrowed a term from evolutionary biology; *exaptation* "the process by which features acquire functions for which they were not originally adapted or selected". During this conference, G20 witnessed an exaptation. This essentially economic bloc, took cognizance of the threats posed by the new and emerging technologies in the cyberspace, came together to improve their understanding of the issues and vowed to address the collective concerns with the sense of urgency it warrants.

Through this initiative under its G20 Presidency, India has made cyber security and crime a global priority, sending a clear message that it is committed to making the cyberspace future safe for this one family that inhabits this one earth. It is hoped that such conferences become a permanent fixture in the G20 Calendar in the years to come. ■





**T**he Third G20 Finance Ministers and Central Bank Governors (FMCBG) meeting, chaired by Union Minister of Finance and Corporate Affairs Nirmala Sitharaman and Governor of Reserve Bank of India Shaktikanta Das, was held in Gandhinagar, Gujarat. During the meeting, members discussed the key deliverables of the Finance Track under India's G20 Presidency for 2023. The members also discussed the global economic outlook and risks, including macroeconomic implications of food and energy insecurity as well as climate change and endorsed the 'G20 Report on Macroeconomic Risks Stemming from Climate Change and Transition Pathways'. There was a recognition of the need for strengthening Multilateral Development Banks (MDBs) to address global challenges of the 21st century, and in this context members appreciated the efforts of the G20 Independent Expert Group on Strengthening MDBs constituted by the Indian Presidency earlier this year. With regard to managing global debt vulnerabilities, a significant

priority area for 2023, G20 Members actively deliberated on how to strengthen multilateral coordination to effectively address the deteriorating debt situation and facilitate coordinated debt treatment for debt-distressed countries. The G20 encouraged the efforts of the Global Sovereign Debt Roundtable (GSDR), chaired by India, IMF and the World Bank, towards strengthening communication among key stakeholders to facilitate effective debt treatment.

The Ministers and Governors lauded India's pioneering

efforts in leveraging Digital Public Infrastructure (DPI) to accelerate financial inclusion as they also acknowledged the transformative role of DPI in rapidly advancing financial inclusion and productivity gains. While noting that harnessing DPIs can help countries to leapfrog their development trajectories, the members unanimously endorsed the 'G20 Policy Recommendations for Advancing Financial Inclusion and Productivity Gains through Digital Public Infrastructure developed under India's G20 Presidency. ■

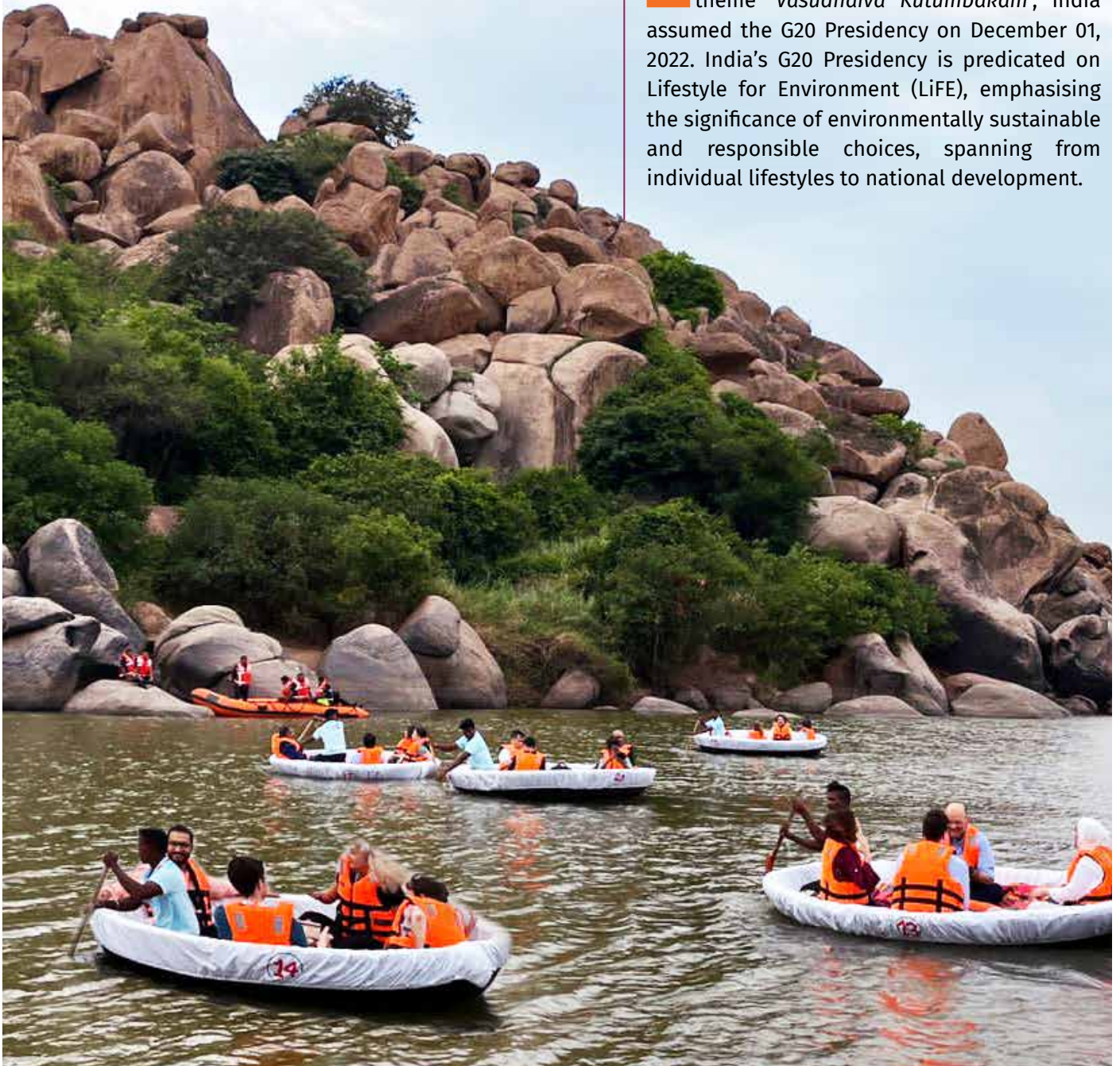

Embodying the concept of 'One Earth, One Family, One Future', through the theme 'Vasudhaiva Kutumbakam', India assumed the G20 Presidency on December 01, 2022. India's G20 Presidency is predicated on Lifestyle for Environment (LiFE), emphasising the significance of environmentally sustainable and responsible choices, spanning from individual lifestyles to national development.





The CWG, under India's G20 Presidency, strives to position culture at the heart of policymaking by articulating and enhancing collaboration on the four priority areas - Protection and Restitution of Cultural Property, Harnessing Living Heritage for a Sustainable Future, Promotion of Cultural and Creative Industries and Creative Economy, and Leveraging Digital Technologies for the Protection and Promotion of Culture.

The 3rd CWG meeting under India's G20 Presidency was organised from July 09-12, 2023 in Hampi, Karnataka, with the participation of representatives from G20 members, invitee countries, and invited international organisations. Continuing the momentum from the First CWG meeting in Khajuraho in February 2023, the expert-driven Global Thematic Webinars in March-April 2023 and the Second CWG meeting in Bhubaneswar in May 2023, the draft declaration was discussed during the third meeting in Hampi.

Shri Pralhad Joshi, Union Minister of Parliamentary Affairs, Coal and Mines, addressed the delegates at the inaugural session of the 3rd CWG meeting and appreciated the insights, comments, and feedback on the text of the Draft 1 of the Joint Ministerial Declaration, highlighting that they will prove instrumental in shaping our shared vision for an inclusive and sustainable future. The 3rd CWG meeting consisted of sessions to discuss the text of Draft 1 of the Joint Ministerial Declaration and the Terms of Reference of the CWG. These sessions, spread over two days, entailed inputs by G20 members, guest nations, and international organisations. At the end of the sessions, an update on G20 Cultural Projects and the Global Thematic Webinar Report to be launched at the Culture Ministers' Meeting was given.

Recognising the unique yet interconnected nature of diverse cultures, highlighting the commonalities that bind societies together, the 'Culture Unites All' campaign was launched at the first G20 CWG meeting in Khajuraho. It aims to serve as a call to embrace and celebrate the shared elements among diverse cultures worldwide. By valuing and promoting cultural diversity as a source of strength, the campaign aims to foster unity and appreciation among nations.

As a part of the hallmark campaign 'Culture Unites All', CWG of India's G20 Presidency, Ministry of Culture, Government of India, set the Guinness World Record for the 'largest display of Lambani items' during the 3rd G20 CWG meeting at Hampi, Karnataka. Over 450 Lambani women artisans and cultural practitioners associated with Sandur Kushala Kala Kendra came together to create these items using GI-tagged Sandur Lambani embroidery. This display titled 'Threads of Unity' celebrated the aesthetic expressions, living heritage and identity of the Lambani community. This initiative is

congruent with the third priority of the CWG, 'Promotion of Cultural and Creative Industries and Creative Economy', as it spotlights the rich artistic tradition and design vocabulary and the economic empowerment the craft brings to the women of the Lambani community.

An exhibition titled 'Woven Narratives' was curated by the G20 CWG under India's Presidency in Hampi Art Labs with the support of JSW Foundation. This specially curated exhibition was inaugurated during the G20 Sherpa Meeting by Shri Amitabh Kant, India's G20 Sherpa.

Engaging with the third priority of the CWG, the exhibition 'Woven Narratives' focused on Indian handlooms as one of the important sectors of the cultural and creative economy of the country. Handlooms across the regions of India may be seen as forming specific economic sectors, while expressing varied individual, social and cultural meanings for the communities involved in their production, trade, and use. The selection of textile-exhibits represented India's diverse geographical, distinct ecologies and creative contexts by narrating their histories and design features, as well as the aesthetic and technical connections some of them share with other parts of the world. Handwoven textiles, in this way, became metaphors for both national identities as much as for the recognition of shared global cultures.

The delegates also embarked on an excursion to the Hampi Group of Monuments, a UNESCO World Heritage Site. It included guided tours of several sites like the Vijaya Vittala Temple and the Royal Enclosure. They also experienced the delightful coracle ride on the scenic Tungabhadra River. The delegates were treated to a captivating percussion recital by the esteemed Guru Shri Vikku Vinayakram and a graceful Indian classical dance performance by Guru Radha and Raja Reddy troupe directed by Guru Kausalya Reddy. The delegates

also participated in Yoga and meditation sessions at the Hazara Rama Temple.

Looking forward and building on the discussions in the 3rd G20 CWG, the 4th CWG concludes the negotiations on the Joint Ministerial Draft which has been through multiple reviews indicating a thorough process of taking the membership's view into consideration to achieve consensus on action-oriented outcomes of the priority areas with the aim of placing culture at the heart of global policies.

Additionally, an exhibition 'Domains of Wonder' has been conceptualised for the 4th G20 CWG meeting in Varanasi, aligning with the CWG's fourth priority: 'Leveraging Digital Technologies for Protection and Promotion of Culture'. Through the integration of immersive technology, custom-produced visuals and music, it is envisaged to showcase the limitless possibilities of representing culture through leveraging technology. 'Domains of Wonder' aims to bring together enchanting tales from across the globe, weaving a tapestry that celebrates the diversity of human imagination and expressions.

Another cultural project, 'Sur Vasudha' or a treasure trove of melodies celebrates the rich musical knowledge and heritage of G20 member nations and invitee countries. As a universal language, music unites people across cultures. In the spirit of *Vasudhaiva Kutumbakam*, the concert will incorporate the music and musical instruments from the G20 members and invitee countries. This shared platform for musicians aims to promote inclusion and diversity, and encourage exchange of ideas and international collaboration through music.

The 4th G20 Culture Working Group meeting is set to convene in Varanasi from August 23-25, 2023, which will be followed by the Culture Ministers' Meeting, scheduled for August 26, 2023. ■

Civil20 (C20) is the official Engagement Group of the G20 that provides a space for Civil Society Organisations (CSO) to voice the people's aspirations with the G20 world leaders. Under the guidance of its Chair Sri Mata Amritanandamayi, a

world-renowned humanitarian and spiritual leader, and Sherpa Amb. Vijay Nambiar, the Secretariat RMP, partner institutions Vivekananda Kendra and Satsang Foundation, led by Sri Mata Amritanandamayi, the C20 fulfilled its role in bringing together the staggering number of CSOs in a country as diverse as India and formulating the Policy Pack for the purview of the G20. Over the past 8 months, C20 reached out to more than 4.5 million people, including representatives of small grassroots and large-scale CSOs, government representatives, multilateral agencies such as the UN, experts, academics, youths, students, and other

G20 Working and Engagement Groups, who participated in an unprecedented number of events and outreach campaigns organised by C20. More than 1,300 events, including policy dialogues, chaupals, samajshalas, in-person workshops, and online webinars, were conducted from January until July 2023. Mass outreach campaigns (Jan Bhagidari) focusing on various areas such as health (999 Challenge), environment (Seedball Campaign), democracy (Democracy Light), gender equality (Million Lights) and technology (GLIDES) were conducted across India and abroad. Overall, 154 countries participated, illuminating the globe with the C20 tagline “You are the Light.” In addition, 427 social workers across 43 countries conducted a Worldwide Grassroots Survey between February 24 and March 15, 2023. Over 8,000 completed surveys were analyzed. Our hope is to recommend a future worldwide survey of ordinary people who would be representative of the population of each country. It should tackle current events and be relevant to contemporary issues, and could be used as preliminary information gathering in the planning process of the C20 policy recommendations.

The C20 guiding principles include its global character, transparency, independence, collaboration, human rights, inclusiveness, continuity, and predictability. This year, C20 covered a wide range of priority issues for civil society through the following 16 Working

Diversity, Inclusion, Mutual Respect; 13. SDG 16+ and Promoting Civic Space; 14. Delivering Democracy – Retrospect and Prospects; 15. Disability, Equity, Justice (DEJ); 16. Special Committee on Financial Issues.

The C20 Chair's leadership provided many unique and valuable contributions, including a basis strongly rooted in compassion and humanistic values guiding the journey. C20 India's ethos of inclusivity and collaboration was manifested in inviting all participating CSOs to share worldwide best practices (udaharans) and white papers; all are published and freely available. This indicates the spirit of the G20 theme – One Earth, One Family, One Future – an ethos that can only be achieved through working collectively with open mutual sharing.

On the 29th, 30th and 31st of July, 2023, C20 successfully held its Final Summit in Jaipur, with more than 1,090 delegates from India and around the globe participating.

A 240-paged Policy Pack encapsulating policies from the 16 Working Groups, developed in collaboration with more than 5,400 CSOs, was released, representing the culmination of the work of C20.

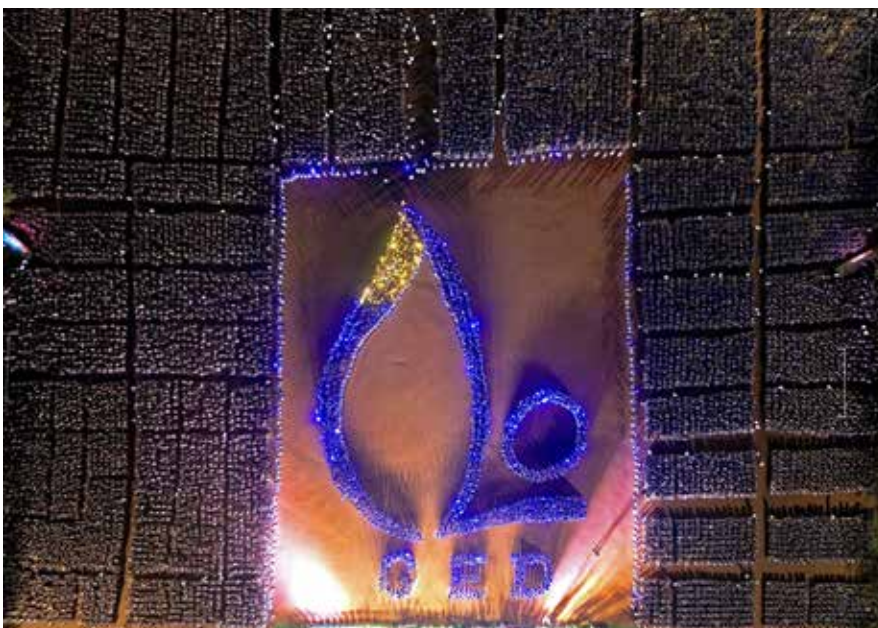

The Summit spanned three days, with an inaugural session followed by five plenary panel discussions with keynote speakers from across the world and 20 breakout rooms dedicated to the themes of the 16 Working Groups. The Summit concluded with a resounding Valedictory Session. Each Working Group conveyed its findings and policy recommendations to be submitted to the G20 for a better future. Crosscutting recommendations included promoting collaboration between civil societies and governments, multilateral and multi-stakeholder efforts, and enhancing public knowledge of pressing issues. The Summit involved more than 180 civil society organisations and 300 international delegates from 40 countries.

The C20 Chair Amma said, “One of the key insights that arose from the deliberations was that, in order to ensure the long-term existence and safety of humanity, it is necessary to embrace certain overarching values and principles, and work together as a unified whole. Indeed, the emergence of such a sentiment can be seen as a positive sign, opening the path for hope.” ■

## SCIENCE20 SUMMIT

It was sometime around autumn the previous year when we started our first discussions on the Science20 theme for our Presidency. I was brought into the discussion early on, immediately after I became President Elect of the Indian National Science Academy. I fondly remember deliberating on terms and ideas over and over with colleagues across the country. I have been a great supporter of the democratic process of crowdsourcing ideas, it makes the process more inclusive and diverse. Many interesting and useful ideas emerged; some of them got us excited, and finally what passed the sieves on the importance and relevance were three main pillars of our scientific and cultural modernity.

One, that our societies can only develop sustainably if we have clean and responsible sources and technologies for energy. Of course, the sources or technologies must be distributed inclusively, justly, and equitably. The notion of justice and the mechanisms of its implementation in the clean energy transition thus soon became central to our discourse.

The second thing that reached its pinnacle was the universal and holistic understanding of health. We have learnt in our experience and understanding that a lot of wisdom is stored in sources that remain hidden, not because it can't be deciphered and even advanced further, but because we arrogantly ignore it. This irrational distaste keeps us from utilizing ideas that can be of potential benefit to humankind. Therefore, we decided that we need to deliberate on a holistic understanding of health and have an inclusive approach to how we deal with healthcare. The central notion of inclusivity does not limit itself to creating a holistic system of approach, but also of delivering it to the last person out there, and that's why holistic health needs to be universal.

The third and the foundational argument that we decided to place at the global stage for debate is the nature of interactions of science with society and culture. The first realisation was that there's an acute need to make a myriad of these connections first, which are often limited to science reaching society through industry and its products. There's a need for strengthening the interfaces of science with society, as well as inventing new ones. For example, by working together with the ecosystems of invention (science) and innovation (socio-economic impact) in a seamless manner.

These three ideas are seemingly disjointed, that is what all of us thought but then we realised that in the context of global modernity, all of them amalgamate in the notion of sustainable development which then became the exhorted theme. We decided that we would consider these ideas for strongly encouraging sustainable development, but with what lens and which context?

I fondly remember the Prime Minister mentioning, I believe it was at the Indian National Science Congress, that, "the pursuit of *vigyan* (i.e. Science) is fulfilled through achievement of two objectives. The first is, generation of profound or disruptive knowledge. The second is consumption of that knowledge for socio-economic good". Throughout the process, we kept reminding ourselves of that. But there was one more thing. It was the generation watching us and their generations to come.

When I looked back to my tenure not only as an academic but also as a scientific bureaucrat, I went through layers and layers of reflections, both internally and with colleagues. We all kept revolving around disruptions, disruptive science and technology. Just when the boom of generative AI happened late in 2022, it was a pleasant realisation, that disruptions need to be the key to

our context. Therefore, the theme of the year became 'Disruptive Science for Sustainable Development'. This was later revised to be called 'Transformative Science for Sustainable Development' when several of our colleagues from member-state academies reached out to us. The term disruption had a perception issue and therefore, we revised it to transformative.

The notion of disruptive science is pioneering or groundbreaking research or innovations that bring about transformational advancements, characterized by exponential growth potential, immense scalability, and unprecedented speed of impact. It revolutionizes existing paradigms, propelling breakthroughs across various disciplines. By rapidly challenging conventions and unlocking new possibilities, disruptive science drives radical positive change, fostering societal progress and addressing complex challenges with remarkable efficiency and effectiveness.

Having said that, disruptive science stands in stark contrast to the concept of "business as usual", which has proven insufficient in accelerating development, achieving sustainability, or ensuring responsibility. While disruptive science fosters transformational advancements with exponential growth potential and scalability, the traditional approach tends to maintain existing paradigms, inhibiting radical positive change.

Disruptive science's unprecedented speed of impact challenges conventional practices and unlocks novel possibilities, enabling remarkable efficiency in addressing complex challenges. "Business as usual" often lacks the agility and innovative spirit necessary to keep up with the dynamic demands of society and the environment, hindering its ability to drive long-lasting progress and positive societal impact which will become the legacy

and the burden of the current generation.

To us, youth was of paramount importance to the process, because truly it is their world now, we are just custodians handing over the charge to them. We ran the entire process making us accountable to the generation that is watching us, by having them in the process, and walking a mile with them so that they can run the next cycles for the generations to come.

Through this year's process, recognizing the role of transformative science in advancing sustainable development, the S20 affirmed the role of strengthening international cooperation to help achieve clean energy for a green and just future, universal holistic health, and having better pathways for connecting science to society, culture and heritage. This is in line with past G20 and S20 declarations and will also build upon efforts already being undertaken by the G20 member states. Such cooperation is expected to accelerate global transformation towards sustainable development.

We have agreed to create a mechanism for just and equitable energy access that aims to greatly accelerate clean energy efforts across the developing world, thereby ensuring that the ongoing clean energy transition truly

leaves no one behind.

We acknowledged that there needs to be an improved understanding of universal and integrative holistic health with focus on well-being and wellness rather than specific dimensions of health. Generation and dissemination of accurate health information and strengthening microbial surveillance and prediction systems, monitoring wildlife, veterinary populations and human communities are all important to enable early detection and prediction of potential pathogens with pandemic potential.

We agreed to initiate a Global Digital Heritage Initiative, which is aimed at preserving global heritage, both tangible and intangible, through the application of digital and cyber-physical technologies. This initiative will represent a paradigm shift in the way we harness the transformative potential of science and technology to both preserve and broaden access to the rich heritage and culture from all G20 countries and other parts of the world.

We also agreed to initiate an international consultative mechanism between scientists, policymakers, and government on Emerging Technologies, which will serve as a critical venue to generate and disseminate knowledge and insights to help navigate the interfaces between science, technology, law, and policy. This, in turn, will promote responsible and inclusive governance of disruptive technologies and ensure that we can enhance the tremendous potential benefits of such innovations for all, while anticipating and minimizing the risks from them.

In this time of transition, it was a great exercise to conduct G20 science deliberations in a rapidly changing country, amidst global lack of stability, with the youth of the world watching us and holding us accountable. We may have invented a new language which was required for the new world, in which poetry will be written by the generations to come, when we are lost in time. ■

# Trade & Investment Working Group

## 3rd MEETING

— JULY 10-12, 2023 | KEVADIA —



**T**he 3rd meeting of the Trade and Investment Working Group (TIWG) under India's G20 Presidency concluded in July in Ekta Nagar (Kevadia), Gujarat. Over 75 delegates from G20 members, invitee countries, regional groupings and international organisations gathered to initiate text-based negotiations on the key deliverables related to spurring integration of MSMEs in global trade, developing a mapping framework for Global Value Chains (GVCs) and enunciating principles for a seamless transition to paperless trade.

On the first day, a seminar on Trade Infrastructure was organised by the Department for Promotion of Industry and Internal Trade (DPIIT) in collaboration with Confederation of Indian Industry. The seminar had two thematic panel discussions on the Role of Logistics in Expanding Global Value Chains and MSME Integration with GVCs. Eminent speakers from India and abroad discussed processes and methods to strengthen physical and digital infrastructure that can lead to a robust logistics ecosystem, thus supporting international trade. The seminar was followed by a

guided tour of the Statue of Unity, Ekta Mall and Sardar Sarovar Dam, and a gala dinner hosted by the State Government for all G20 delegates.

On the substantive front, TIWG is pursuing five priority issues related to trade and investment, namely:

- ◆ Trade for Growth and Prosperity
- ◆ Resilient Trade and GVCs
- ◆ Integrating MSMEs in Global Trade
- ◆ Logistics for Trade
- ◆ WTO Reforms

During the first two meetings held in Mumbai and Bengaluru respectively, the above priority issues were extensively discussed among the G20 member/invitee countries. Presentations made by the Knowledge Partners during the first two meetings outlined the outcomes emerging from these priorities.

Based on the suggestions and interventions expressed during the first two TIWG meetings, Indian Presidency has formulated action-oriented and concrete key





deliverables which include:

- ◆ High-Level Principles on Digitalization of Trade Documents
- ◆ Call for Action to foster integration of MSMEs in Global Trade
- ◆ G20 Generic Framework for Mapping Global Value Chains (GVCs)

The above deliverables were welcomed by the G20 countries, and during the next two days of the meeting, intense negotiations on the proposals made by the Presidency on these deliverables ensued. Particularly, High-Level Principles on Digitalization of Trade Documents and Call for Action for integrating MSMEs in global trade were discussed on July 11, 2023. On the next day, outcome pursuant to developing a G20 Generic Framework for Mapping Global Value Chains (GVCs) was deliberated. It was agreed that such a framework would serve as a useful reference to pursue coordinated policy actions among countries to enhance GVC resilience.







During the three days of meeting in Kevadia, an experience zone was set up by the Tea Board of India, and an exhibition zone was set up by DPIIT and National Industrial Corridor Development Corporation (NICDC). The experience zone displayed India's rich heritage of tea, aromatic spices, millets and coffee, and the exhibition zone showcased India's initiative in strengthening trade infrastructure and logistics. The viewing galleries set up

at the exhibition zone included achievements of PM Gati Shakti, and a demo of NICDC's Multimodal Connectivity, National Logistics Policy and Unified Logistics Interface Platform.

The fourth and final TIWG meeting will be held in Jaipur on 21st & 22nd August, 2023 and followed by the Trade and Investment Ministers' Ministerial Meeting at the same venue on 24th & 25th August, 2023. ■



# Leveraging the New Space Era for Economic Growth

**T**he field of space technology has made a profound impact on the quality of living of the human race and the world's dependence on space and space assets is growing day by day. Space Technology plays a significant role in furthering social well-being and sustainable growth. Thus, it has a very crucial role in achieving the 17 global Sustainable Development Goals by 2030 and creating equitable prosperity for all.

Having said that, I believe that space activities also have a huge potential to move beyond the pillars of development and national prestige to profitable business and economy, and in fact, become a

significant contributor to economic growth. Globally, these are very exciting times for the space industry, and we are witnessing a major transformation. The



space sector is entering into a new era – from extra-terrestrial exploration to declining launch costs to highly advanced earth observation capabilities. In this new era, the opportunity presented by the space sector for private industries is huge. The current \$447 billion industry is expected to cross \$1 trillion by 2040 (Source: Morgan Stanley). To fully leverage this opportunity, it is imperative for nations to come together and collaborate on multiple fronts in the space sector.

Hence the focus of the 4th Edition of the G20 Space Economy Leaders Meet (SELM) organized in Bengaluru on July 6-7, 2023, by the Department of Space, under India's G20 Presidency, was in line with the overall objective of fostering collaboration through bilateral and multilateral partnerships. This year's SELM theme was "Towards a New Space ERA (Economy, Responsibility, Alliance)", echoing the relevance of New Space in shaping the global economy. The future of the space economy is closely linked to the advancement of New Space Era. Even though the New Space is growing steadily, the growth needs to be sustained through well-thought-out governmental policy interventions, to enable conducive policy regimes for enhanced space industry collaborations globally. The deliberations in G20 SELM were instrumental in creating a common understanding among the participating countries on the significance of Economy, Responsibility, Alliance in the new space era.

This global event in Bengaluru witnessed the participation of heads and senior representatives of space agencies of 18 G20 countries, 8 invited countries and an international organization (International Telecommunication Union) to deliberate on the efforts of respective nations to advance the space economy. Apart from these, 32 overseas and 53 Indian companies engaged in space activities also actively participated in the two-day deliberations. Thirty Indian space industry start-ups were provided an opportunity to showcase their capabilities at a space exhibition, along with Exhibits from ISRO/DOS and Government of Karnataka.

Sustainable Development Goals (SDGs), the Paris Agreement and the Kunming-Montréal Global Biodiversity Framework within this 'Decade of Action'. We urge national governments to acknowledge the crucial role local and subnational governments play in realizing the 2030 Agenda as shown by the Voluntary Local Reviews and that could be reinforced by the Global Stocktake at COP28.

Therefore, our Communiqué puts forth strategic recommendations under the six categories, namely: Encouraging Environmentally Responsible Behavior; Ensuring Water Security; Accelerating Climate Finance; Championing 'Local' Culture and Economy; Reinventing Frameworks for Urban Governance and Planning; and Catalyzing Digital Urban Futures to solicit global support and national interventions that enable cities to take further action in addressing the pressing challenges faced by our planet. 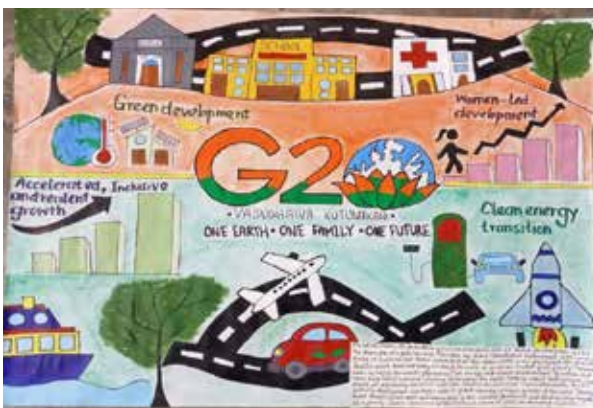

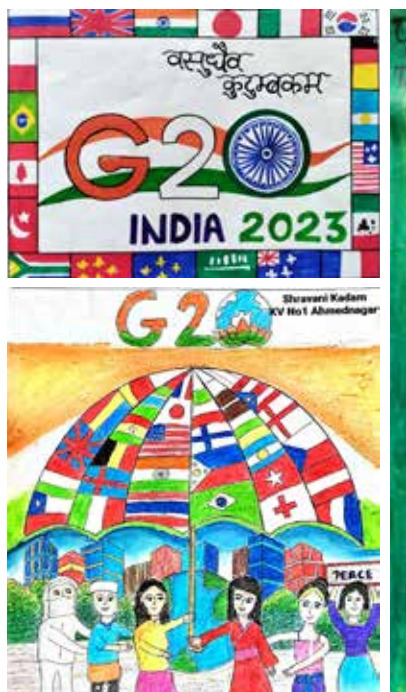

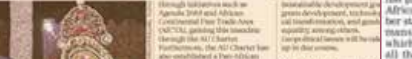
